Kforce, Inc. (“KFRC”) has transferred primary listing from the Nasdaq Stock Market to the New York Stock Exchange (“NYSE”) on Monday, May 20, 2024. As set forth in MIAX Options Rule 503(d), MIAX Pearl Rule 503(a)(3) and MIAX Emerald Rule 503(d), the exchanges shall use NYSE as the “market for the underlying security” for the purpose of Openings on the Exchange.
