The Options Clearing Corporation (OCC) has been informed that ACE Limited (ACE) will change its name, trading symbol, and CUSIP to Chubb Limited (CB), CUSIP H1467J104 effective January 15, 2016. As a result, option symbol ACE will change to CB effective at the opening of business on **January 19, 2016**.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol CB commencing January 19, 2016.
