Arch Coal, Inc. (ACI) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each ACI Common Share will be converted into the right to receive 0.10 (New) Arch Coal, Inc. Common Shares. The reverse stock split will become effective at the market open on August 4, 2015.
