On October 22, 2015, Hoffman Acquisition Corporation, a wholly-owned subsidiary of a wholly owned subsidiary of OMRON Corporation, completed its tender offer for Adept Technology, Inc. (ADEP) Common Shares. The subsequent merger was completed on October 23, 2015. As a result, each existing ADEP Common Share will be converted into the right to receive \$13.00 net cash per share.

PER CONTRACT: \$1,300.00 (\$13.00 x 100)

Settlement in ADEP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Adept Technology, Inc. options whose expiration dates are after 11-20-2015 will have their expiration dates advanced to 11-20-2015. Expiration dates occurring before 11-20-2015 (e.g., Flex options) will remain unchanged.

All Adept Technology, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 11-20-2015

Existing American-style Adept Technology, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
