Alliance Data Systems Corporation (ADS) will change its name and trading symbol to Bread Financial Holdings, Inc. (BFH) effective April 4, 2022. As a result, option symbols ADS/ADS1 will also change to BFH/BFH1 effective at the opening of business on April 4, 2022.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols BFH/BFH1 commencing April 4, 2022.
