On August 18, 2017, Shareholders of Albany Molecular Research, Inc. (AMRI) voted concerning the proposed merger with a wholly-owned subsidiary of UIC Parent Corporation, which was formed by affiliates of GTCR LLC and The Carlyle Group. The merger was approved and subsequently consummated on August 31, 2017. As a result, each existing AMRI Common Share will be converted into the right to receive \$21.75 net cash per share.

CONTRACT ADJUSTMENT

PER CONTRACT: \$2,175.00 Cash (\$21.75 x 100)

Settlement in AMRI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Albany Molecular Research, Inc. options whose expiration dates are after 9-15-2017 will have their expiration dates advanced to 9-15-2017. Expiration dates occurring before 9-15-2017 (e.g., Flex options) will remain unchanged.

All Albany Molecular Research, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 9-15-2017

Existing American-style Albany Molecular Research, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
