On May 6, 2016, Shareholders of Apollo Education Group, Inc. (APOL) voted concerning the proposed merger with Socrates Merger Sub, Inc., a wholly-owned subsidiary of AP VIII Queso Holdings, L.P., which was formed by affiliates of Apollo Management VIII, L.P. The merger was approved and subsequently consummated on February 1, 2017. As a result, each existing APOL Class A Common Share will be converted into the right to receive \$10.00 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLE
PER CONTRACT: \$1,000.00 Cash (\$10.00 x 100)

Settlement in APOL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Apollo Education Group, Inc. options whose expiration dates are after 2-17-2017 will have their expiration dates advanced to 2-17-2017. Expiration dates occurring before 2-17-2017 (e.g., Flex options) will remain unchanged.

All Apollo Education Group, Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 2-17-2017

Existing American-style Apollo Education Group, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
