BlackSky Technology Inc. (BKSJ) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each BKSJ Class A Common Share will be converted into the right to receive 0.125 (New) BlackSky Technology Inc. Class A Common Shares. The reverse stock split will become effective before the market open on September 9, 2024. Cash will be paid in lieu of fractional shares.

Pricing

Until the cash in lieu amount is determined, the underlying price for BKSJ1 will be determined as follows:

$$\text{BKSJ1} = 0.125 (\text{BKSJ})$$

Delayed Settlement

The BKSJ component of the BKSJ1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the BKSJ1 deliverable until the cash in lieu of fractional BKSJ Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
