Peabody Energy Corporation (BTU) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each BTU Common Share will be converted into the right to receive approximately 0.066667 (New) Peabody Energy Corporation Common Shares. Cash will be paid in lieu of fractional shares. The reverse stock split will become effective before the market open on October 1, 2015.

PRICING

Until the cash in lieu amount is determined, the underlying price for BTU1 will be determined as follows:

$$\text{BTU1} = 0.066667 \text{ (BTU)}$$

DELAYED SETTLEMENT

The BTU component of the BTU1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the BTU1 deliverable until the cash in lieu of fractional BTU Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
