DELAYED SETTLEMENT

OCC will delay settlement of the cash portion of the CHL1 deliverable until final net dividend amount is determined. Upon determination of the final net dividend amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
