Cheetah Mobile Inc. (CMCM) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each CMCM American Depositary Share will be converted into the right to receive 0.20 (New) Cheetah Mobile Inc. American Depositary Shares. The reverse stock split will become effective before the market open on September 2, 2022.
