On February 26, 2015, Shareholders of Cleco Corporation (CNL) voted concerning the proposed merger with Como 3 Inc., a wholly-owned subsidiary of Como 1 L.P., an entity formed by a consortium of investors. The merger was approved and subsequently consummated on April 13, 2016. As a result, each existing CNL Common Share will be converted into the right to receive \$55.37 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLE

PER CONTRACT: \$5,537.00 Cash (\$55.37 x 100)

Settlement in CNL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Cleco Corporation options whose expiration dates are after 5-20-2016 will have their expiration dates advanced to 5-20-2016. Expiration dates occurring before 5-20-2016 (e.g., Flex options) will remain unchanged.

All Cleco Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: CNL

Existing Expiration: All months New expiration date: 5-20-2016

Existing American-style Cleco Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
