On November 19, 2014, Shareholders of Concur Technologies, Inc. (CNQR) voted concerning the proposed merger with Congress Acquisition Corp., a wholly-owned subsidiary of SAP America, Inc. The merger was approved and subsequently consummated on December 4, 2014. As a result, each existing CNQR Common Share will be converted into the right to receive \$129.00 net cash per share.

#### **CONTRACT ADJUSTMENT**

NEW DELIVERABLE  
PER CONTRACT: \$12,900.00 Cash (\$129.00 x 100)

Settlement in CNQR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Concur Technologies, Inc. options whose expiration dates are after 12-20-2014 will have their expiration dates advanced to 12-20-2014. Expiration dates occurring before 12-20-2014 (e.g., Flex options) will remain unchanged.

All Concur Technologies, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: CNQR  
Existing Expiration: All months  
New expiration date: 12-20-2014

Existing American-style Concur Technologies, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
