The Options Clearing Corporation (OCC) has been informed that Coach, Inc. (COH) will change its name, trading symbol and CUSIP to Tapestry, Inc. (TPR), CUSIP 876030107. As a result, option symbols COH/1COH will also change to TPR/1TPR effective at the opening of business on October 31, 2017.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols TPR/1TPR commencing October 31, 2017.
