SETTLEMENT/ACCELERATION OF EXPIRATIONS

On June 22, 2016, Shareholders of Columbia Pipeline Group, Inc. (CPGX) voted concerning the proposed merger with a wholly-owned subsidiary of TransCanada PipeLine USA Ltd., a wholly-owned subsidiary of TransCanada PipeLines Limited. The merger was approved and subsequently consummated before the open on July 1, 2016. As a result, each existing CPGX Common Share will be converted into the right to receive \$25.50 net cash per share.

**CONTRACT ADJUSTMENT**

NEW DELIVERABLE  
PER CONTRACT: \$2,550.00 Cash (\$25.50 x 100)

Settlement in CPGX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Columbia Pipeline Group, Inc. options whose expiration dates are after 7-15-2016 will have their expiration dates advanced to 7-15-2016. Expiration dates occurring before 7-15-2016 (e.g., Flex options) will remain unchanged.

All Columbia Pipeline Group, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 7-15-2016

Existing American-style Columbia Pipeline Group, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
