The Options Clearing Corporation (OCC) has been informed that Communications Sales & Leasing, Inc. (CSAL) will change its name, trading symbol and CUSIP to Uniti Group Inc. (UNIT), CUSIP 91325V108. As a result, option symbol CSAL will also change to UNIT effective at the opening of business on February 27, 2017.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol UNIT commencing February 27, 2017.
