Neuralstem, Inc. (CUR) has announced a 1-for-13 reverse stock split. As a result of the reverse stock split, each CUR Common Share will be converted into the right to receive approximately 0.076923 (New) Neuralstem, Inc. Common Shares. Fractional CUR shares will be rounded up to the next whole share. The reverse stock split will become effective before the market open on January 9, 2017.
