On September 16, 2015, holders of Cablevision Systems Corporation (CVC) Class B Shares representing in excess of a majority of the shareholder voting power, adopted the Merger agreement with Neptune Merger Sub Corporation, a wholly owned subsidiary of Altice N.V. The merger was consummated before the open on June 21, 2016. As a result, each existing CVC Class A Share will be converted into the right to receive \$34.90 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLE

PER CONTRACT: \$3,490.00 Cash (\$34.90 x 100)

Settlement in CVC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Cablevision Systems Corporation options whose expiration dates are after 7-15-2016 will have their expiration dates advanced to 7-15-2016. Expiration dates occurring 7-15-2016 (e.g., Flex options) will remain unchanged.

All Cablevision Systems Corporation options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 7-15-2016

Existing American-style Cablevision Systems Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
