### **PRICING**

## **BACKGROUND**

Community Health Systems, Inc. (CYH) has announced a distribution of (New) Quorum Health Corporation (QHC) Common Shares. The distribution ratio is 0.25 of a QHC share for each CYH share held. The record date is April 22, 2016; the payable date is April 29, 2016. The New York Stock Exchange (NYSE) has set May 2, 2016, as the ex-distribution date for this distribution.

Quorum Health Corporation Common Shares began trading on a when issued basis on April 20, 2016 on the New York Stock Exchange under the trading symbol "QHC WI".
