Pricing

Until cash in lieu amount is determined, the underlying price for CSAN1 will be determined as follows:

$$\text{CSAN1} = 1.29401595263 (\text{CSAN})$$

Delayed Settlement

OCC will delay settlement of the CSAN component and cash portion of the CSAN1 deliverable until regular way trading commences and cash in lieu of fractional CSAN ADSs is determined. Upon the commencement of regular way trading and determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the CSAN ADSs and the appropriate amount of cash.

Background

On January 22, 2021, Shareholders of Cosan Limited (CZZ) approved the proposed merger with Cosan S.A. (CSAN). The merger was subsequently consummated on March 5, 2021. As a result, each existing

CZZ Class A Common Share will be converted into the right to receive 1.29401595263 CSAN American Depositary Shares. Cash will be paid in lieu of fractional CSAN ADSs.

Cosan S.A. American Depositary Shares are anticipated to start trading “when-issued” on NYSE on March 8, 2021 under the trading symbol “CSAN WI” and are anticipated to start trading “regular-way” on NYSE on March 11, 2021 under the trading symbol “CSAN”.
