On February 12, 2015, Shareholders of Digital River, Inc. (DRIV) voted concerning the proposed merger with a wholly-owned subsidiary of Danube Private Holdings II, LLC, an affiliate of Siris Capital Group, LLC. The merger was approved and subsequently consummated on February 12, 2015. As a result, each existing DRIV Common Share will be converted into the right to receive \$26.00 net cash per share.

## **CONTRACT ADJUSTMENT**

DATE: February 13, 2015

NEW DELIVERABLE

PER CONTRACT: \$2,600.00 Cash (\$26.00 x 100)

Settlement in DRIV options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Digital River, Inc. options whose expiration dates are after 2-20-2015 will have their expiration dates advanced to 2-20-2015. Expiration dates occurring before 2-20-2015 (e.g., Flex options) will remain unchanged.

All Digital River, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: DRIV

Existing Expiration: All months New expiration date: 2-20-2015

Existing American-style Digital River, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
