Discovery Laboratories, Inc. (DSCO) has announced a 1-for-14 reverse stock split. As a result of the reverse stock split, each DSCO Common Share will be converted into the right to receive approximately 0.07142857 (New) Discovery Laboratories, Inc. Common Shares. The reverse stock split will become effective before the market open on January 22, 2016.

#### **DELAYED SETTLEMENT**

The DSCO component of the DSCO1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the DSCO1 deliverable until the cash in lieu of fractional DSCO Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
