SUBJECT: DYAX CORPORATION –CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS OPTION SYMBOL: DYAX DATE: 1/22/16

On January 21, 2016, Shareholders of Dyax Corporation (DYAX) voted concerning the proposed merger with Parquet Courts, Inc., a wholly-owned subsidiary of Shire Pharmaceuticals International. The merger was approved and subsequently consummated before the opening of business on January 22, 2016. As a result, each existing DYAX Common Share will be converted into the right to receive \$37.30 net cash per share plus one non-transferrable Contingent Value Right (CVR).

NOTE: The Contingent Value Rights represent a non-transferrable contractual right to receive an additional payment upon the achievement of a specified milestone as described in the DYAX Proxy Statement dated December 14, 2015. DYAX options will not be adjusted to call for the delivery of the CVRs.

Settlement in DYAX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Dyax Corporation options whose expiration dates are after 2-19-2016 will have their expiration dates advanced to 2-19-2016. Expiration dates occurring before 2-19-2016 (e.g., Flex options) will remain unchanged.

All Dyax Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: DYAX Existing Expiration: All months New expiration date: 2-19-2016 Existing American-style Dyax Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
