Emerald Oil Inc. (EOX) has announced a 1-for-20 reverse stock split, **which was approved by shareholders on May 20, 2015.** As a result of the reverse stock split, each EOX Common Share will be converted into the right to receive 0.05 (New) Emerald Oil Inc. Common Shares. The reverse stock split will become effective at the market open on **May 21, 2015**.
