Equinor ASA (EQNR) has announced an Extraordinary Cash Dividend of \$0.5868 (\$0.70 gross dividend less 15% Norwegian withholding tax, and \$0.0082 fees) per EQNR American Depositary Share. The record date is January 10, 2023; the payable date is January 25, 2023. The ex-distribution date for this distribution will be January 9, 2023.
