EnteroMedics Inc. (ETRM) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each ETRM Common Share will be converted into the right to receive approximately 0.06667 (New) EnteroMedics Inc. Common Shares. Fractional shares will be rounded up to the nearest whole share. The reverse stock split will become effective at the market open on January 7, 2016.
