FuelCell Energy, Inc. (FCEL) has announced a 1-for-12 reverse stock split. As a result of the reverse stock split, each FCEL Common Share will be converted into the right to receive approximately 0.083333 (New) FuelCell Energy, Inc. Common Shares. The reverse stock split will become effective before the market open on December 4, 2015.

#### **PRICING**

Until the cash in lieu amount is determined, the underlying price for FCEL1 will be determined as follows:

$$\text{FCEL1} = 0.083333 (\text{FCEL})$$

#### **DELAYED SETTLEMENT**

The FCEL component of the FCEL1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the FCEL1 deliverable until the cash in lieu of fractional FCEL Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
