Forge Global Holdings, Inc. (FRGE) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each FRGE Common Share will be converted into the right to receive approximately 0.066667 (New) Forge Global Holdings, Inc. Common Shares. The reverse stock split will become effective before the market open on April 15, 2025. Cash will be paid in lieu of fractional shares.

Pricing

Until the cash in lieu amount is determined, the underlying price for FRGE1 will be determined as follows:

$$\text{FRGE1} = 0.066667 (\text{FRGE})$$

Delayed Settlement

The FRGE component of the FRGE1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the FRGE1 deliverable until the cash in lieu of fractional FRGE Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
