FXCM Inc. (FXCM) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each FXCM Class A Common Share will be converted into the right to receive 0.10 (New) FXCM Inc. Class A Common Share. The reverse stock split will become effective at the market open on October 1, 2015.
