AdvisorShares Ranger Equity Bear ETF (HDGE) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each HDGE share will be converted into the right to receive 0.10 (New) AdvisorShares Ranger Equity Bear ETF shares. The reverse stock split will become effective before the market open on February 8, 2021.
