Defiance Next Gen H2 ETF (HDRO) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each HDRO Share will be converted into the right to receive 0.125 (New) Defiance Next Gen H2 ETF Shares. The reverse stock split will become effective before the market open on October 7, 2024. Cash will be paid in lieu of fractional shares.

Delayed Settlement

The HDRO component of the HDRO1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the HDRO1 deliverable until the cash in lieu of fractional HDRO Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
