Harvest Natural Resources, Inc. (HNR) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each HNR Common Share will be converted into the right to receive 0.25 (New) Harvest Natural Resources, Inc. Common Shares. The reverse stock split will become effective before the market open on November 4, 2016.
