iShares Core MSCI Emerging Markets ETF (IEMG) has announced a Special Cash Dividend of \$0.293222 per IEMG Share. The record date is December 17, 2019; the payable date is December 20, 2019. The ex-distribution date for this distribution will be December 16, 2019.

NOTE: IEMG options will be adjusted to reflect the \$0.293222 special cash distribution on December 16, 2019 by including a cash component with the IEMG deliverable in the amount of the distribution (x 100), as described below. Effective December 17, 2019, the IEMG deliverable will no longer include the cash component, and IEMG strikes will be reduced by 0.293222 and rounded to the nearest penny.
