iShares Core MSCI Emerging Markets ETF (IEMG) has announced a Special Cash Dividend of \$0.293222 per IEMG Share. The record date is December 17, 2019; the payable date is December 20, 2019. The ex-distribution date for this distribution will be December 16, 2019.

NOTE: IEMG options will be adjusted to reflect the \$0.293222 special cash distribution on December 16, 2019 by including a cash component with the IEMG deliverable in the amount of the distribution (x 100), as described below. Effective December 17, 2019, the IEMG deliverable will no longer include the cash component, and IEMG strikes will be reduced by 0.293222 and rounded to the nearest penny.

CONTRACT ADJUSTMENT

EFFECTIVE DATE: December 16, 2019

NEW MULTIPLIER: 100 (e.g., for premium extensions a premium of 1.50 equals \$150.00; a strike of 30.00 yields \$3,000.00).

CONTRACT MULTIPLIER: 1

STRIKE PRICES: **12-16-19** - Strike prices will remain unchanged (IEMG deliverable will include cash component for distribution amount as described below for one day only)
12-17-19 - Strike prices will be reduced by 0.293222 and rounded to the nearest penny. (For example, a strike of 37 will be reduced to 36.71; a strike of 41 will be reduced to 40.71)

OPTION SYMBOL: IEMG remains IEMG
