iShares U.S. Energy ETF (IYE) has announced a Special Cash Dividend of \$1.022644 per IYE Share. The record date is December 17, 2019; the payable date is December 20, 2019. The ex-distribution date for this distribution will be December 16, 2019.

NOTE: IYE options will be adjusted to reflect the \$1.022644 special cash distribution on December 16, 2019 by including a cash component with the IYE deliverable in the amount of the distribution (x 100), as described below. Effective December 17, 2019, the IYE deliverable will no longer include the cash component, and IYE strikes will be reduced by 1.022644 and rounded to the nearest penny.
