On July 19, 2017, Shareholders of KCG Holdings, Inc. (KCG) voted concerning the proposed merger with Orchestra Merger Sub, Inc., an indirect wholly owned subsidiary of Virtu Financial, Inc. The merger was approved and subsequently consummated before the open on July 20, 2017. As a result, each existing KCG Class A Common Share will be converted into the right to receive \$20.00 net cash per share.

## **CONTRACT ADJUSTMENT**

DATE: July 20, 2017

NEW DELIVERABLE

PER CONTRACT: \$2,000.00 Cash (\$20.00 x 100)

Settlement in KCG/1KCG options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of KCG Holdings, Inc. options whose expiration dates are after 8-18-2017 will have their expiration dates advanced to 8-18-2017. Expiration dates occurring before 8-18-2017 (e.g., Flex options) will remain unchanged.

All KCG Holdings, Inc. options will utilize a \$.01 exercise threshold.

Option Symbols: KCG/1KCG Existing Expiration: All months New expiration date: 8-18-2017

Existing American-style KCG Holdings, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
