The Options Clearing Corporation (OCC) has been informed that Key Energy Services, Inc. (KEG) will change its trading symbol to KEGX, due to the listing of the company on an OTC market. As a result, option symbol KEG will also change to KEGX effective at the opening of business on July 28, 2016.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol KEGX commencing July 28, 2016.
