On January 12, 2016, Shareholders of King Digital Entertainment Public Limited Company (KING) voted concerning the proposed merger with ABS Partners C.V., a wholly-owned subsidiary of Activision Blizzard, Inc. The merger was approved and subsequently consummated before the opening of business on February 23, 2016. As a result, each existing KING Ordinary Share will be converted into the right to receive \$18.00 net cash per share.

## **CONTRACT ADJUSTMENT**

DATE: February 23, 2016

NEW DELIVERABLE

PER CONTRACT: \$1,800.00 Cash (\$18.00 x 100)

Settlement in KING options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of King Digital Entertainment Public Limited Company options whose expiration dates are after 3-18-2016 will have their expiration dates advanced to 3-18-2016. Expiration dates occurring 3-18-2016 (e.g., Flex options) will remain unchanged.

All King Digital Entertainment Public Limited Company options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 3-18-2016

Existing American-style King Digital Entertainment Public Limited Company options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
