The Options Clearing Corporation (OCC) has been advised that Springleaf Holdings, Inc. (LEAF) will change its name, trading symbol and CUSIP to OneMain Holdings, Inc. (OMF), CUSIP 68268W103. As a result, option symbol LEAF will also change to OMF effective at the opening of business on November 27, 2015.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol OMF commencing November 27, 2015.
