On August 19, 2016, Shareholders of LinkedIn Corporation (LNKD) voted concerning the proposed merger with Liberty Merger Sub Inc., a wholly-owned subsidiary of Microsoft Corporation. The merger was approved and subsequently consummated before the open on December 8, 2016. As a result, each existing LNKD Common Share will be converted into the right to receive \$196.00 net cash per share.

CONTRACT ADJUSTMENT

PER CONTRACT:** \$19,600.00 Cash (\$196.00 x 100)

Settlement in LNKD options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of LinkedIn Corporation options whose expiration dates are after 12-16-2016 will have their expiration dates advanced to **12-16-2016**. Expiration dates occurring before 12-16-2016 (e.g., Flex options) will remain unchanged.

All LinkedIn Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 12-16-2016

Existing American-style LinkedIn Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in three business days.
