Loma Negra Compania Industrial Argentina Sociedad Anonima (LOMA) has announced a payment in-kind dividend of Argentinian Republic Treasury Bills to ordinary shareholders in the home market. Since the dividend in-kind cannot be distributed to ADR holders, JPMorgan, as Depositary, announced that it has sold securities representing the bonds received in this pay in kind dividend and will distribute \$0.3530086 (\$0.4010845 less \$0.0280759 withholding tax, less \$0.02 dividend fee) per LOMA American Depositary Share. The record date is May 15, 2023; the payable date is May 18, 2023. The ex-distribution date for this distribution will be May 12, 2023.
