LSB Industries, Inc. (LXU) declared a 30% Stock Dividend to LXU Shareholders. The Payable Date is October 8, 2021. The Record Date is September 24, 2021. The New York Stock Exchange (NYSE) has set October 12, 2021 as the ex-distribution date for this stock dividend. The dividend was contingent upon closing of the preferred stock exchange transaction described in the LXU Proxy Statement dated August 26, 2021. Closing was announced by LXU on September 27, 2021.
