DATE: November 9, 2021

Pursuant to Minneapolis Grain Exchange, LLC (MGEX™) Rules, the Exchange will not be open for business for Corporate Tax, Hard Red Spring Wheat (HRSW), BRIXX™ and Ag Index trading (cash, futures and options) on Thursday, November 25, 2021. Additionally, the evening session for these contracts will not be available the night before. However, please note that SPIKES® Futures are open for a limited Trading Session beginning Wednesday, November 24, 2021 and continuing until a 10:30 a.m. CT halt on Thursday, November 25, 2021 (trade date November 26, 2021).
