The Options Clearing Corporation (OCC) has been informed that McGraw Hill Financial, Inc. (MHFI) will change its name, trading symbol, and CUSIP to S&P Global Inc. (SPGI), CUSIP 78409V104. As a result, option symbol MHFI will also change to SPGI effective at the opening of business on April 28, 2016.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol SPGI commencing April 28, 2016.
