The Options Clearing Corporation (OCC) has been informed that The Men's Wearhouse, Inc. (MW) will change its name, trading symbol and CUSIP to Tailored Brands, Inc. (TLRD), CUSIP 87403A107. As a result, option symbol MW will also change to TLRD effective at the opening of business on February 1, 2016.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol TLRD commencing February 1, 2016.
