On September 15, 2017, Shareholders of ClubCorp Holdings, Inc. (MYCC) voted concerning the proposed merger with a subsidiary of Constellation Club Parent, Inc., both formed by funds managed by affiliates of Apollo Management VIII, L.P. The merger was approved and subsequently consummated on September 18, 2017. As a result, each existing MYCC Common Share will be converted into the right to receive \$17.12 net cash per share.

CONTRACT ADJUSTMENT

NEW DELIVERABLE

PER CONTRACT: \$1,712.00 Cash (\$17.12 x 100)

Settlement in MYCC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of ClubCorp Holdings, Inc. options whose expiration dates are after 10-20-2017 will have their expiration dates advanced to 10-20-2017. Expiration dates occurring before 10-20-2017 (e.g., Flex options) will remain unchanged.

All ClubCorp Holdings, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: MYCC

Existing Expiration: All months New expiration date: 10-20-2017

Existing American-style ClubCorp Holdings, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
