SPIKES Futures

Please note that with the expiration of April SPIKES futures, the May SPIKES futures contract will now be considered the front month and will be charged *Month 1* margin rates. All other deferred contract months will move up in priority in their respective order.

These changes are effective for positions held at the close of business on **Wednesday**, **April 19**, **2023**.
