The Options Clearing Corporation (OCC) has been advised that NII Holdings, Inc. (NIHD) will change its trading symbol to NIHDQ due to listing on an Over the Counter Market. As a result, option symbol NIHD will also change to NIHDQ effective at the opening of business on September 25, 2014.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol NIHDQ commencing September 25, 2014.
