Natural Resource Partners L.P. (NRP) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each NRP Common Unit will be converted into the right to receive 0.10 (New) Natural Resource Partners L.P. Common Units. The reverse stock split will become effective before the market open on February 18, 2016.
