Owlet, Inc. (OWLT) has announced a 1-for-14 reverse stock split. As a result of the reverse stock split, each OWLT Common Share will be converted into the right to receive approximately 0.071428571 (New) Owlet, Inc. Common Shares. The reverse stock split will become effective before the market open on July 10, 2023.

Until the cash in lieu amount is determined, the underlying price for OWLT1 will be determined as follows:

$$\text{OWLT1} = 0.071428571 (\text{OWLT})$$

## **Delayed Settlement**

The OWLT component of the OWLT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the OWLT1 deliverable until the cash in lieu of fractional OWLT Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
